#### TERMS AND CONDITIONS

### A. The Responsibility and Duty of the Registered Company

#### **B.** Confidentiality

The detail information acquired during the job shall not be disclosed or released to third party without permission of the applicant or this Society.

## C. Scope and Limitation

The extent of engagement is limited to the scope stated on this Certificate unless attached otherwise.

#### D. Renewal of the Approval

Renewal audit should be carried out within 3 months before the expiry date of Certificate. However, the validity of new Certificate will be started from the next day of expiry date of previous Certificate.
